

Declaration of Conformity to EU RoHS 3 and REACH

Wiltan Ltd certifies that all products delivered are fully compliant with the European Union RoHS Directive 2011/65/EU, as amended by Directive (EU) 2015/863 (RoHS 3) and Directive (EU) 2024/232. This compliance ensures that hazardous substances in electrical and electronic equipment are restricted according to the specified limits.

The following substances are restricted under the RoHS Directive, with maximum concentration values (MCVs) in homogeneous materials as follows:

Lead (Pb)	< 0.1% by weight (1000 ppm)
Mercury (Hg)	< 0.1% by weight (1000 ppm)
Cadmium (Cd)	< 0.01% by weight (100 ppm)
Hexavalent Chromium (Cr (VI))	< 0.1% by weight (1000 ppm)
Polybrominated Biphenyls (PBB)	< 0.1% by weight (1000 ppm)
Polybrominated Diphenyl Ethers (PBDE)	< 0.1% by weight (1000 ppm)
Bis(2-Ethylhexyl) phthalate (DEHP)	< 0.1% by weight (1000 ppm)
Benzyl butyl phthalate (BBP)	< 0.1% by weight (1000 ppm)
Dibutyl phthalate (DBP)	< 0.1% by weight (1000 ppm)
Diisobutyl phthalate (DIBP)	< 0.1% by weight (1000 ppm)

In accordance with Directive (EU) 2024/232, Wiltan Ltd acknowledges the inclusion of an exemption for cadmium and lead in recovered rigid PVC materials used in electrical and electronic windows and doors. The concentration of cadmium shall not exceed 0.1% by weight, and lead shall not exceed 1.5% by weight in recovered rigid PVC material. This exemption is valid until May 28, 2028.

Wiltan Ltd also notes the potential future addition of Tetrabromobisphenol A (TBBP-A) and Medium-chain chlorinated paraffins (MCCPs) to the restricted substances list, pending approval by the European Commission. Wiltan will ensure compliance with these substances should they be officially restricted.

Wiltan Ltd remains committed to monitoring ongoing updates to the RoHS Directive and will take immediate action to ensure continuous compliance. We guarantee that all products delivered comply with the latest RoHS directives and regulations.

REACH

Wiltan Ltd certifies that all products delivered are fully compliant with the European Union REACH regulation (Registration, Evaluation, Authorization, and Restriction of Chemicals), as per Regulation (EC) No 1907/2006. This ensures that no products contain Substances of Very High Concern (SVHC) above the threshold limit of 0.1% by weight unless specified.

As of June 27, 2024, the ECHA Candidate List contains 241 substances of very high concern (SVHC). Wiltan Ltd guarantees that none of the listed SVHCs is present in our products above the permitted threshold.

Wiltan Ltd will continue to evaluate any changes to the REACH regulations, including updates to the Candidate List. We will ensure compliance with any future regulations or amendments and notify customers accordingly.
